#### APPROVAL OF AGENDA

#### APPROVAL OF MINUTES

Motion by Knutson to approve the minutes from July 9, 2013 Town Board meeting. Seconded by Knutson. All aye. Motion carried.

## TREASURER'S REPORT

# FIRE DEPARTMENT REPORT AND APPROVAL OF PURCHASES

Jake Lobermeier was present and gave an oral and written report to the board. There were 7 calls during the last month. All vehicles are currently in service. The Tomahawk Fire School is in September and we have 7 fire fighters going.

### FIRST RESPONDER'S REPORT AND APPROVAL OF PURCHASES

Greg Zeske was present and gave an oral report to the board. There were 8 calls last month and no purchases. Bruce Germond stated that he would help with planning for the park on the new property.

#### COUNTY BOARD SUPERVISOR'S REPORT

Bob Martini gave an oral report to the board. There was no County Board meeting this past month. There were committee meetings to discuss broadband options and there is a meeting on Thursday to discuss NR115 and shoreland zoning.

#### LIBRARY REPORT

Harry Whidden gave an oral report to the board. They have completed the 2014 library budget and there is a slight increase but was bare necessities. There is a meeting on the 20th to sit down with the planning committee for the library expansion.

#### TOWN PLAN COMMISSION REPORT

Treder gave an oral report to the board. They discussed the 2 property divisions, Denton and Howard and will be recommending approval for both properties.

#### TOWN LAKES COMMITTEE REPORT

Joel Knutson gave an oral report to the board. They met on August 3 and this was the least attended meeting due to the County Fair. The committee discussed the Squash Lake Boat landing and had a local contractor look at it. They also discussed grants available for clean boats, clean water. There was also a discussion about motor vehicle traffic on lakes and concerns about drag racing. Specific concerns mentioned were 1) Maintaining Lake Health 2) Trash 3) Noise 4) Public Safety. The Committee is proposing that an ordinance be created to stop drag racing. Sample documents they will present to the Town Board: Town of Merrill ordinance, a resolution to govern events on lake ice proposed by the Crescent Lake Association, and the United States Forest Service special event permit application (a general use permit offered for comparative purposes).
