**CALL TO ORDER**

Chairman William Treder called the Annual Town Meeting to Order at 7:00 p.m. Roll Call was taken. Other town officials in attendance were:

**APPROVAL OF AGENDA**

**READING OF MINUTES OF THE ANNUAL TOWN MEETING HELD APRIL 14, 2009.**

Motion was made by Harry Whidden to waive the reading of the Annual Town Meeting held April 14, 2009. Seconded by Don Kress. Vote was taken. Aye – 10, Nay – 0, Motion carried.

**FINANCIAL REPORT**

Copies of the Annual Financial Report were distributed to those in attendance.

Motion was made by Bettinger to accept the Annual Financial Report. Seconded by Harry Whidden. Vote was taken. Aye – 10, Nay – 0, Motion carried.

**ANY OTHER BUSINESS THAT LAWFULLY COMES BEFORE THE BOARD**

Treder stated that the Board will be meeting with the Road crew soon to look at all Town Roads and determine what roads will be repaved this year. Turgeon stated that he would like to see Long Lake Rd finished and work done on N Fox Ranch Rd and Wausau Rd.

Kuczarski stated that he would like to see a written accounting of what the town crews hours are and what they do during that time. G. Hartman stated that open records gives access to all of those records, however, if he wants a copy of them there is a fee, otherwise he can contact the clerk and arrange a time to view the records. Kuczarski also stated that there used to be a road supervisor that would hand out weekly job assignments.

Janet Appling stated that there are pot holes on Crescent Road by the Town Pump and is wondering if it is Oneida Counties responsibility to fix them. Don Kress stated that they can not be fixed until the weight limits are off.

Kuczarski stated that he still has concerns that his property does not fall in general use zoning and he wants his property zoned general use. Treder stated that aside from shoreland zoning all of Crescent is general zoning.
