## **TOWN OF CRESCENT MINUTES OF THE ANNUAL TOWN MEETING TUESDAY, APRIL 16, 2013 7:00 P.M., CRESCENT TOWN HALL**

### **CALL TO ORDER**

Chairman William Treder called the Annual Town Meeting to Order at 7:04 p.m. Roll Call was taken. Other town officials in attendance were:

### **READING OF MINUTES OF THE ANNUAL TOWN MEETING HELD APRIL 10, 2012.**

Motion was made by Ken Orton to waive the reading of the Annual Town Meeting held April 10, 2012. Seconded by Joel Knutson. Vote was taken. Aye 9, Nay – 0, Motion carried.

Motion was made by Bob Martini to approve the minutes of the annual Town Meeting held on April 11, 2012. Seconded by Don Kress. Aye 9, Nay-0.

### **FINANCIAL REPORT**

Copies of the Annual Financial Report were distributed to those in attendance.

Motion was made by Bob Martini to accept the Annual Financial Report. Seconded by Ken Orton. Vote was taken. Aye - 9, Nay – 0, Motion carried.

### **ANY OTHER BUSINESS THAT LAWFULLY COMES BEFORE THE BOARD**

In regards to the assessors annual report Bob Martini asked if the whole town is going to be reassessed due to being over the state limit. T. Hartman stated that Mike Schnautz will be doing a complete reassessment this year due to the numbers being too high. This will include home visits on all homes in Crescent.

Treder reported that it was at last years annual meeting that the electorate approved the Board to pursue purchasing/swapping land that is next to the current town hall/fire department property. Today at 1:00 p.m. Treder went to the Title company and closed on the land swap. The Board is looking forward to hearing from members of the fire department and residents as to what can be done with the land. Orton stated that the fire department would like to put a pavilion on the new land. Turgeon thanked Treder for taking on this project and working for the last year to get this accomplished.

Bob Martini raised his concern that he believes that it is important for the Town to look into racing that is occurring on the larger lakes throughout the state. He thinks the town should look into an ordinance that puts restrictions (who cleans up, number of people) on these types of the events. The Town of Merrill has an ordinance that gives these restrictions. Martini would like to see the Town Lakes Committee look into this possibility.

Motion was made by Bob Martini to adjourn the Annual Town Meeting. Seconded by Connie Anderson. Vote was taken. Aye-9, Nay – 0, Motion carried.
