**APPROVAL OF AGENDA**

**TREASURER'S REPORT**

A written report was received by Treasurer, Carla Fletcher.

**FIRE DEPARTMENT REPORT AND APPROVAL OF PURCHASES**

Jake Lobermeier gave an oral and written report to the board. There were 8 calls in the month of January. A natural gas leak, 2 carbon monoxide alarms, car fire, power lines on fire, fire alarm, chimney fire and snowmobile accident. Training in February is Indoor Search and Rescue, FIT Testing, and Patient Movement Techniques. Training in March is Wild land Firefighting and April training is Water Operations. All equipment is in service.

**FIRST RESPONDER'S REPORT AND APPROVAL OF PURCHASES**

Jake Lobermeier gave an oral report for the first responders. There were 13 calls in the month of January and no purchases.

**TOWN ROAD CREW REPORT**

Mike Bess was present and gave an oral report to the board. Bess stated that everything is going well right now. They are on track with salt sand for the winter. Richardson asked when the no stop on right sign will be removed on N Rifle Rd. Bess stated that it will be removed on the next quiet day.

**COUNTY BOARD SUPERVISOR'S REPORT**

Robb Jensen gave an oral and written report to the board. Jensen reported that there was a Forest-Oneida-Vilas county Transit Commission and Forest county has decided to leave that commission. Jensen reported that they are working on an overall safety improvement plan with a current insurance company. They are receiving applications for a new Highway Commissioner

as Freeman Bennett will be retiring. They are also looking at the highway shop and what needs to be upgraded. The UW Extension will be reorganizing due to some budget cuts. They are looking at combining 4 counties under one administrator. Jensen attended a legislative meeting with the Counties association. One of the things that came up was having a meeting periodically between county board members and municipal town board members to discuss local issues.

#### LIBRARY REPORT

Harry Whidden was present and gave an oral and written report to the board. There have been 4 building committee meetings in the last few months. They have a building manager that is supervising construction of the expansion if it does happen. They have a meeting on the 26th with the building managers to look at all of the rooms and discuss what is needed.

#### TOWN PLAN COMMISSION REPORT

Richardson reported that they met on February 1 to discuss the Eagle's Way subdivision. The plan commission has a recommendation for the board.
