REVIEW AND DISCUSSION OF THE PROPOSED 2026 TOWN BUDGET

Clerk Hartman reviewed the proposed 2026 budget which includes the base levy of \$651,315 and a loan payment of \$112,524 for a total levy of \$763,839.00.

SET TAX LEVY FOR 2025 TO BE COLLECTED IN 2026

Motion was made by Carla Fletcher to approve the town levy at \$763,839.00 for 2025 collected

in 2026. Seconded by Keven Mahner. Vote was taken. Aye 18, Nay 0; motion carried.

Keven Mahner requested approval from the town electors to put up a training center on the old town dump. This training center would be built using two storage containers. Chair Hartman stated that this has been staked out and there have been no issues noted. Jacobson stated that there will be a gravel pad to place the storage containers on. Motion by Jacobson to allow the CVFD to setup the two storage containers as a training center in the specified zone at the town dump. Seconded by Mehring. Aye 18, Nay 0; motion carried.

Dan Mehring asked where things are at with the Squash Lake Boat Landing. Chair Hartman stated that a consultant has been hired to assist with the DNR permit needed for the boat landing. Mehring questioned if pads are needed or if it could be left as gravel.

Motion was made by Jonathan Jacobson to adjourn the Special Town Meeting of the Electorate at 5:23 p.m. Seconded by Paul Frey. Vote was taken. All aye; Motion carried.
